

Privacy Statement

American Special Risk, LLC is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the American Special Risk, LLC Web site and governs data collection and usage. By using the American Special Risk, LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

American Special Risk, LLC collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Use of your Personal Information

Use of Cookies
